For people of all ages and financial circumstances, having a giving plan is an important way to steward God's blessings wisely.




Consult an attorney. You and your attorney can develop a plan that addresses your priorities for your family and the charities you wish to support while minimizing tax liabilities.

## What is the best planned giving option?

**Bequests** are gifts you leave through your will, either a fixed amount or the remainder of your estate after family and friends have been provided for. Life Income Gifts (Trusts) provide income for yourself or a loved one while helping the sisters. Trusts offer a variety of tax benefits. Consulting your attorney maximizes benefits to all.

**Insurance Policies** often allow for a larger gift than would be otherwise possible and include significant tax savings. The Dominican Sisters of Springfield, IL, can be designated as a beneficiary for a new or existing policy.

**Retirement Plan Gifts** allow you to name the Dominican Sisters of Springfield, IL, as a beneficiary, and use other lower-taxed assets to provide for loved ones. This may help you avoid heavier taxation in your plan.

Lifetime Gifts carry immediate tax benefits are available when you make an outright gift of cash, stock, bonds, transferable stock options, or other assets. The assets are generally taxdeductible in the year given. Through careful financial planning we hope that you will be able to find a gift option that will benefit you and your family, as well as the Dominican Sisters.
